Cash Gift Using Enterprise Zone Benefits

The State Legislature created the Colorado State Enterprise Zone Program to address economic distress in designated geographical areas in Colorado. Part of the program consists of tax credits for community projects approved by the Economic Development Commission that implement the overall Economic Development Plan of the Enterprise Zone. The Fort Morgan Community Hospital Association has been selected for one of these projects whereby an additional tax benefit is afforded to our contributors. For all gifts over \$50, a tax credit of 25% of the annual gift will be deducted from the Colorado State Income tax return. Both cash and in-kind contributions are eligible. When making your gift, *your check must be made out to NE Colorado Enterprise Zone/Fort Morgan Community Hospital Association*. Your tax EIN or social security number must also be submitted to the Administrator of the Northeast Colorado Department of Local Governments to complete the transaction.
